Based on exploration of the above, we discussed the following as possible ideas for development:

The aim is be able to follow up our forum at 2015 Climate Week with something sufficiently in place for implementation. We discussed a three track approach:

- A subscription model, easy in, easy out, less payback.
- A PPA offering, vetted, better terms, better deal, tiered pricing based on the community's level of participation, as Solarize. More commitment, better payback.
- A Coop member ownership model, greatest commitment, best payback including tax credits and SRECs.

Willy Osborn and David Lescohier will schedule meetings regarding the above and report in November.

In addition, we learned about and discussed the possible use of the Brookline Audi dealer site coupled with planned reconstruction. Rob Daves lives in the area and is a TMM. He will take the lead and include Werner Lowe and Willy Osborn if it seems a meeting would be worthwhile.
